[Executive Order 2020-142](#) “provides a structure to support all schools in Michigan as they plan for a return of pre-K-12 education in the fall. Under the order, school districts must adopt a COVID-19 Preparedness and Response Plan laying out how they will cope with the disease across the various phases of the [Michigan Safe Start Plan](#). In turn, the accompanying Michigan Return to School Roadmap offers a guide to the types of safety protocols appropriate during each phase. There’s no one-size-fits-all solution: What works in Lansing may not work in Sault Sainte Marie. Districts will retain the flexibility to tailor their instruction to their particular needs and to the disease conditions present in their regions.” (EO-2020-142)

If schools are unable to meet the strongly recommended actions, an explanation is listed below.

## Phase 4

### Personal Protective Equipment

<i>Required (Michigan Safe Schools Roadmap, pg 22)</i>
Facial coverings must always be worn by staff except for meals. Facial coverings may be homemade or disposable level-one (basic) grade surgical masks. Any staff member who cannot medically tolerate a facial covering must not wear one. Any staff member that is incapacitated or unable to remove the facial covering without assistance, must not wear a facial covering.
PreK-5 and special education teachers should consider wearing clear masks.
Facial coverings must be worn by preK-12 students, staff, and bus drivers during school transportation. Any staff or student that is unable to medically tolerate a facial covering must not wear one. Any staff or student that is incapacitated or unable to remove the facial covering without assistance, must not wear one. Facial coverings may be homemade or disposable level-one (basic) grade surgical masks.
Facial coverings must always be worn in hallways and common areas by preK-12 students in the building except for during meals. Any student that is unable to medically tolerate a facial covering must not wear one. Any student that is incapacitated or unable to remove the facial covering without assistance, must not wear one. Facial coverings may be homemade or disposable level-one (basic) grade surgical masks.
Note: Students with significant disabilities preventing the use of facial coverings are referred to forthcoming guidance from MDE.

Return to School Roadmap  
 Protocols: Phase 4 (Required - Strongly Recommended)

Facial coverings must be worn in classrooms by all students grades 6-12. Any student who cannot medically tolerate a facial covering must not wear one. Any student who is incapacitated, or unable to remove the facial covering without assistance, must not wear one.	
All students in grades K-5 must wear facial coverings unless students remain with their classes throughout the school day and do not come into close contact with students in another class.	
<i>Strongly Recommended</i>	<i>School's explanation if not able to meet:</i>
Facial coverings should be considered for K-5 students and students with special needs in classrooms.	K-5 students are encouraged to wear masks in the classroom, but are not required. Students will remain with their class throughout the school day.
Facial coverings should be considered for preK students and students with special needs in hallways and common areas.	Sacred Heart Academy will fully comply with this recommendation.
Facial coverings are not recommended for use in classrooms by children ages 3 and 4	Sacred Heart Academy will fully comply with this recommendation.
Facial coverings should never be used on children under age 2	Sacred Heart Academy will fully comply with this recommendation.

## Hygiene

Provide adequate supplies to support healthy hygiene behaviors (including soap, hand sanitizer with at least 60% alcohol for safe use by staff and students, paper towels, tissues, and signs reinforcing proper handwashing techniques).	
Teach and reinforce handwashing with soap and water for at least 20 seconds and/or the safe use of hand sanitizer that contains at least 60% alcohol.

Educate staff and students on how to cough and sneeze into their elbows, or to cover with a tissue. Used tissues should be thrown in the trash and hands washed immediately using proper hand hygiene techniques	Sacred Heart Academy will fully comply with this recommendation. In classrooms where there are not sinks, students will use hand sanitizer.
Systematically and frequently check and refill soap and hand sanitizers.	Sacred Heart Academy will fully comply with this recommendation.
Students and teachers must have scheduled handwashing with soap and water every 2-3 hours.	Sacred Heart Academy will fully comply with this recommendation. In classrooms where there are not sinks, students will use hand sanitizer.
Limit sharing of personal items and supplies such as writing utensils.	Sacred Heart Academy will fully comply with this recommendation.
Keep students' personal items separate and in individually labeled cubbies, containers, or lockers.	Sacred Heart Academy will fully comply with this recommendation.
Limit use of classroom materials to small groups and disinfect between use, or provide adequate supplies to assign for individual student use.	Sacred Heart Academy will fully comply with this recommendation.
Procure portable handwashing and/or hand sanitizing stations to set up throughout school buildings.	Sacred Heart Academy will fully comply with this recommendation.

Adult guests entering the building should be screened for symptoms, wear a facial covering, and wash/sanitize hands prior to entering. Every school should identify and designate a quarantine area and a staff person to care for students who become ill at school.	Sacred Heart Academy will fully comply with this recommendation.
Students who become ill with symptoms of COVID-19 should be placed in an identified quarantine area with a surgical mask in place until they can be picked up. Identified school staff caring for these children should wear a surgical mask, with the exception of students with special needs requiring aerosolized procedures in which an N95 mask is required.	Sacred Heart Academy will fully comply with this recommendation.
Symptomatic students sent home from school should be kept home until they have tested negative or have completely recovered according to CDC guidelines.	Sacred Heart Academy will fully comply with this recommendation.
Staff should conduct daily self-examinations, including a temperature check, prior to coming to work. If they exhibit any respiratory or gastrointestinal symptoms, or have a temperature of 100.4 or greater, they should stay home.	Sacred Heart Academy will fully comply with this recommendation.

Students who develop a fever or become ill with COVID-19 symptoms at school should wear a mask and be transported by their parent or guardian, emergency contact, or ambulance if clinically unstable, for off-site testing.	Sacred Heart Academy will fully comply with this recommendation.
Staff who develop a fever or become ill with COVID-19 symptoms at school should wear a mask and be transported for off-site testing.	Sacred Heart Academy will fully comply with this recommendation.
Symptomatic students and staff sent home from school should be kept home until they have tested negative for COVID-19, or have been released from isolation according to CDC guidelines.	Sacred Heart Academy will fully comply with this recommendation.
Families should be notified of the presence of any laboratory positive or clinically diagnosed cases of COVID-19 in the school to encourage closer observation for any symptoms at home.	Sacred Heart Academy will fully comply with this recommendation.
In the event of a lab or clinically diagnosed case of COVID-19, immediate efforts should be made to contact any close contacts (those who spent more than 15 minutes less than six feet in close proximity to the student or staff member) so that they can be quarantined for 14 days at home. Students and staff should be closely monitored for any symptoms of COVID-19. At this time, empiric testing of all students or staff members in the class is not recommended. Only those that develop symptoms require testing for COVID-19.	Sacred Heart Academy will fully comply with this recommendation.

<p>Notify local health officials, staff, and students immediately of any possible case of COVID-19 while maintaining confidentiality consistent with the Americans with Disabilities Act (ADA) and other applicable federal and state privacy laws. a</p>	<p>Sacred Heart Academy will fully comply with this recommendation.</p>
<p>The Local Health Department will initiate contact tracing, following regular public health practice. Anyone who was within close contact of the case (less than six feet apart for 15+ minutes) will be asked to self quarantine for up to 14 days after exposure. Local health officials, depending on the situation, may identify other contacts who require quarantine. Schools can help the local health department by collecting data and contact information of those exposed.</p>	<p>Sacred Heart Academy will fully comply with this recommendation.</p>
<p>Employees with a confirmed case of COVID-19 should only return to the workplace after they are no longer infectious. Local health officials will provide instruction about return to work, using the most current guidelines from the CDC for this determination.</p>	<p>Sacred Heart Academy will fully comply with this recommendation.</p>
<p>Cleaning staff should wear a surgical mask, gloves, and a face shield when performing cleaning of these areas.</p>	<p>Sacred Heart Academy will fully comply with this recommendation.</p>

## Athletics

<i>Required (Michigan Safe Schools Roadmap, pg 27)</i>	
Comply with all guidance published by Michigan High School Athletic Association (MHSAA) and the National Federation of State High School Associations (NFHS).	
Students, teachers, and staff must use proper hand hygiene techniques before and after every practice, event, or other gathering. Every participant should confirm that they are healthy and without any symptoms prior to any event.	
All equipment must be disinfected before and after use.	
Inter-school competitions may be held provided that, facial coverings are worn if school transportation is provided. Buses must be cleaned and disinfected before and after every use, as detailed in the subsequent "Busing and Student Transportation" section.	
Spectators are allowed provided that facial coverings are used by observers and six feet of social distancing can be maintained at all times. Attention must given to entry and exit points to prevent crowding. Each participant must use a clearly marked water bottle for individual use. There should be no sharing of this equipment.	
Handshakes, fist bumps, and other unnecessary contact must not occur.	
Indoor weight rooms and physical conditioning activities that require shared equipment are suspended. Outdoor physical conditioning activities are allowed while maintaining social distancing.	
Large scale indoor spectator events are suspended. Large scale outdoor spectator or stadium events are limited to 100 people, and people not part of the same household must maintain six feet of distance from one another.

## Cleaning

<i>Required (Michigan Safe Schools Roadmap, 27)</i>	
Frequently touched surfaces including light switches, doors, benches, bathrooms, must undergo cleaning at least every four hours with either an EPA-approved disinfectant or diluted bleach solution.	
Libraries, computer labs, arts, and other hands-on classrooms must undergo cleaning after every class period with either an EPA-approved disinfectant or diluted bleach solution.	
Student desks must be wiped down with either an EPA-approved disinfectant or diluted bleach solution after every class period.	
Playground structures must continue to undergo normal routine cleaning, but using an EPA approved disinfectant is unnecessary.	
Ensure safe and correct use and storage of cleaning and disinfection products, including storing products securely away from children, and with adequate ventilation when staff use products.	
Staff must wear gloves, surgical mask, and face shield when performing all cleaning activities.

## Busing and Student Transportation

<i>Required (Michigan Safe Schools Roadmap, pg 28)</i>	
Require the use of hand sanitizer before entering the bus. Hand sanitizer must be supplied on the bus.	
The bus driver, staff, and all students in grades preK-12, if medically feasible, must wear facial coverings while on the bus. Note: there may be situations where it is not safe for the bus driver

to wear a facial covering. Decisions about these situations should be made on a case-by-case basis with local public health officials.	
Clean and disinfect transportation vehicles before and after every transit route. Children must not be present when a vehicle is being cleaned.	
Clean and disinfect frequently touched surfaces in the vehicle (e.g., surfaces in the driver’s cockpit, hard seats, arm rests, door handles, seat belt buckles, light and air controls, doors and windows, and grab handles) prior to morning routes and prior to afternoon routes.	
Clean, sanitize, and disinfect equipment including items such as car seats, wheelchairs, walkers, and adaptive equipment being transported to schools daily.	
Create a plan for getting students home safely if they are not allowed to board the vehicle.	
If a student becomes sick during the day, they must not use group transportation to return home and must follow protocols outlined above. If a driver becomes sick during the day, they must follow protocols for sick staff outlined above and must not return to drive students.	
Weather permitting, keep doors and windows open when cleaning the vehicle and between trips to let the vehicles thoroughly air out.	
Weather permitting, consider keeping windows open while the vehicle is in motion to help reduce spread of the virus by increasing air circulation, if appropriate and safe.

Screening instructions (offered verbally to younger students) should provide age-appropriate and transparent disclosure of protocols in place to protect confidentiality while adhering to mandated reporting guidelines.</p>	<p>A screening form will be emailed to all students in grades five through twelve. Parents of pre-k through fourth grade students will receive a paper copy to read to their children. All confidentiality laws will be followed.</p>
